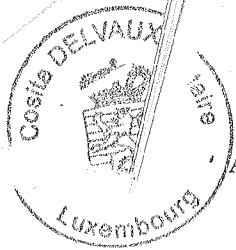

ASSIGNMENT OF INTELLECTUAL PROPERTY RIGHTS

AND

TRACKFIN BV, a limited liability company duly incorporated and existing under the laws of the Netherlands; with registered office in Amsterdam and business office at Waaier 38, 2451 VW, Leimuïden, The Netherlands:

represented by Mrs. Barbara van Welsem, director, hereinafter referred to as:

"the Assignee"

WHEREAS

1. The Assignor is the registered owner of the entire right, title and interest in and to the international trademarks (Appendix A) (hereinafter referred to as the "Intellectual Property Rights");
2. The Assignor is the registered owner of the entire right, title and interest in and to national trademark applications which are in the course of pending registration (hereinafter referred to as the "Trademarks in Registration", and collectively with the Intellectual Property Rights, referred to herein as the "Purchased Property");
3. The Assignee is desirous of acquiring the entire right, title and interest in and to the Purchased Property.

THEREFORE

1. The Assignor, in consideration of the sum of one Euro (€ 1.00,-), exclusive of VAT (the "Purchase Price"), and other good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, does hereby sell, assign,

transfer and set over to the Assignee, all its right, title and interest in and to the Purchase Price and Assignee hereby purchases the Purchased Property;


2. The Assignor hereby authorizes the issuance to said Assignee of any and all patents in any and all countries of the world based on Assignee hereby purchases the Purchased Property., and of the Assignor's entire right, title and interest in and to the same, for the sole use and benefit of said Assignee, its successors, assigns or legal representatives;
3. The Assignor, on its own behalf, and on behalf of its executors and administrators, hereby agrees to do, and shall do all such lawful acts and things and to execute without further consideration such further lawful assignments, documents, assurances, applications, and other instruments as may reasonably be required by said Assignee, its successors, assigns or legal representatives, to obtain any and all patents issuing in any and all countries of the world based on Assignee hereby purchases the Purchased Property and vest the same in said Assignee, its successors, assigns or legal representatives.
4. Payment of the Purchase Price shall be made in full within three weeks after the effective date of this assignment deed.

6. This agreement shall be governed by and construed in accordance with the laws of the Grand Duchy of Luxembourg.
