CERTIFICATE OF AMENDMENT
TO RESTATED ARTICLES OF INCORPORATION OF
AIRTIGHT NETWORKS, INC.

Rick Wilmer and Mike Anthofer hereby certify that:


1. They are the duly elected Chief Executive Officer and Secretary, respectively, of Airtight Networks, Inc., a California corporation (the "*Corporation*").
2. Article I of the Restated Articles of Incorporation, as heretofore amended, is hereby amended to read in its entirety as follows:

"The name of the corporation shall be Mojo Networks, Inc."

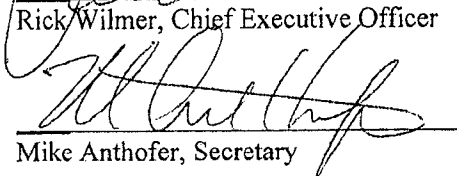
3. The foregoing amendment of the Restated Articles of Incorporation has been duly approved by the board of directors of this corporation in accordance with Section 902 of the California Corporations Code.
4. This Certificate of Amendment of this corporation's Restated Articles of Incorporation has been duly approved by the required vote of shareholders in accordance with Section 902 of the California Corporations Code. The total number of outstanding shares of this corporation entitled to vote with respect to this Certificate of Amendment was 175,007,039, and the total number of shares of preferred stock entitled to vote with respect to this Certificate of Amendment was 141,121,812. The number of shares voting in favor of this Certificate of Amendment of this corporation's Restated Articles of Incorporation equaled or exceeded the vote required. The percentage vote required was a majority of all outstanding shares voting together as a single class, and a majority of all preferred stock voting together as a single class.

The undersigned officers further declare under penalty of perjury under the laws of the State of California that the matters set forth in this Certificate of Amendment are true and correct of their own knowledge.
