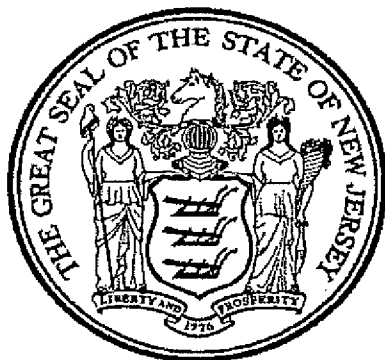

TO THE  
CERTIFICATE OF INCORPORATION**

Pursuant to the provisions of Section 14A:9-2(4) and Section 14A:9-4(3) of the New Jersey Business Corporation Act, this Certificate of Amendment is being filed in order to amend the Certificate of Incorporation of Clement Pappas and Company, Inc. (the "Corporation"), as set forth below:

1. The name of the Corporation is Clement Pappas and Company, Inc.
2. The New Jersey Business Entity Number is 2981701000.
3. The amendment to the Certificate of Incorporation approved by the Board of Directors and adopted by the shareholders is:
