## TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARKS** (this "*Termination and Release*") is granted as of December 17, 2015 by **SILICON VALLEY BANK**, as Administrative Agent (the "*Assignee*"), in favor of **AOD ACQUISITION COMPANY**, a Florida corporation ("*AOD*"), **ADVANCED ANSWERS ON DEMAND HOLDING CORPORATION**, a Florida corporation ("*Advanced Answers*"), **AOD HOLDING COMPANY**, a Delaware corporation ("*Holdings*"), **ADVANCED ANSWERS ON DEMAND INC.**, a Florida corporation ("*AOD Florida*"), **ADVANCED ANSWERS ON DEMAND OF WISCONSIN, INC.**, a Wisconsin corporation ("*AOD Wisconsin*"), and **STRATIS BUSINESS SYSTEMS, INC.**, a Florida corporation ("*Stratis*", and together with AOD, Advanced Answers, Holdings, AOD Florida, and AOD Wisconsin, individually, a "*Grantor*", and collectively, the "*Grantors*").

**WHEREAS**, AOD, Advanced Answers, Holdings, AOD Florida and AOD Wisconsin executed and delivered a Trademark Security Agreement dated as of May 21, 2012 (as amended, modified or supplemented prior to the date hereof, the "*Trademark Agreement*"; capitalized terms used but not defined herein shall have the meaning ascribed to them in the Trademark Agreement), granting the Assignee a security interest in and lien on certain trademarks and trademark applications described therein;

**WHEREAS**, the Trademark Agreement was recorded in the Assignment Division of the United States Patent and Trademark Office on May 21, 2012, at Reel 4784, Frame 0687;

**WHEREAS**, Stratis executed and delivered a Trademark Security Agreement dated as of July 16, 2014 (as amended, restated, supplemented or otherwise modified prior to the date hereof, "*Trademark Agreement #2*" and, together with the Trademark Agreement, collectively, the "*Grants*"), granting the Assignee a security interest in and lien on certain trademarks and trademark applications described therein;

**WHEREAS**, the Trademark Agreement #2 was recorded in the Assignment Division of the United States Patent and Trademark Office ("*USPTO*") on July 17, 2014, at Reel 5324, Frame 0107;

**WHEREAS**, the Grantors have requested that the Assignee hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of the Grantor in, to and under all of the trademarks and trademark applications described in the Grants (collectively, the "*Marks*") as herein provided; and

**WHEREAS**, the Grantors have requested that the Assignee provide a document suitable for recording in the United States Patent and Trademark Office to evidence the release of its security interests in and liens on the Marks as herein provided.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignee hereby:


1. terminates the Grants and releases, terminates and discharges all liens and security interests in each Grantor's right, title and interest in, to and under the Marks, and all goodwill associated therewith, including those Marks identified in Schedule 1 hereto;
2. authorizes and requests that this Termination and Release be recorded at the USPTO; and
3. agrees that it shall, and at any Grantor's, or its respective successor's or assign's, reasonable request, execute, acknowledge and deliver to such Grantor all further releases and other documents, and take all other actions necessary or reasonably desirable for the release of such security interest.

THIS TERMINATION AND RELEASE AND ANY CLAIM, CONTROVERSY, DISPUTE OR CAUSE OF ACTION (WHETHER IN CONTRACT OR TORT OR OTHERWISE) BASED UPON, ARISING OUT OF OR RELATING TO THIS TERMINATION AND RELEASE AND THE TRANSACTIONS CONTEMPLATED HEREBY SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAW OF THE STATE OF NEW YORK.
