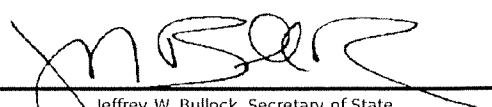

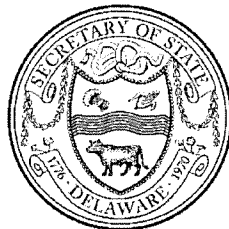

Pursuant to Sections 251 and 264 of the Delaware General Corporation Law and Section 209 of the Delaware Limited Liability Company Act, the undersigned hereby executes the following Certificate of Merger:

FIRST: The surviving corporation is **The Broadlane Group, Inc.**, a Delaware corporation, and the corporations and limited liability companies being merged into this surviving corporation are:

MedAssets Analytical Systems, LLC, a Delaware limited liability company
Dominic & Irvine, LLC, a Delaware limited liability company
MedAssets Supply Chain Systems, LLC, a Delaware limited liability company
Aspen Healthcare Metrics LLC, a Delaware limited liability company
