SCHEDULE A

TRADEMARK ASSIGNMENT

NOW, THEREFORE, in consideration of the mutual promises and covenants set forth in the Trademark Assignment and License Back Agreement, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns, transfers, and conveys to Assignee all Assignor's right, including without limitation, any and all common law rights, title, and interest in and to the Marks and the Registrations, inclusive of the goodwill of the business symbolized by the Marks and the Registrations, and associated therewith.


The Parties may execute this Agreement in one or more counterparts, all of which taken together will constitute one and the same instrument.
