## **PARTIAL RELEASE OF TRADEMARK SECURITY AGREEMENT**

THIS PARTIAL RELEASE OF TRADEMARK SECURITY AGREEMENT (the "Release") is made on this 19<sup>th</sup> day of January, 2016 by Bank of America, N.A., in its capacity as administrative agent for a group of lenders (in such capacity, the "Administrative Agent").

WHEREAS, pursuant to (i) that certain Third Amended and Restated Security Agreement dated of as January 31, 2014, among Hat World, Inc. (the "Grantor"), certain of its affiliates and Administrative Agent (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement") and (ii) that certain Second Amended and Restated Trademark Security Agreement dated January 31, 2014, by and between the Grantor and Administrative Agent (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Trademark Security Agreement"; together with the Security Agreement, the "Security Instruments"), the Grantor pledged and granted to the Administrative Agent a lien on and security interest in and to all of its right, title and interest in those certain Trademarks identified on Exhibit A attached hereto, together with all goodwill associated with such Trademarks and all proceeds of any and all of the foregoing (the "Released Collateral"). Capitalized terms used herein but not otherwise defined shall have the meaning given such terms in the Trademark Security Agreement;

WHEREAS, the security interest granted to the Administrative Agent was recorded at the (i) United States Patent and Trademark Office on February 6, 2014 at Reel 5210 and Frame 0020 and (ii) the Canadian Intellectual Property Office on March 9, 2011 as File No. 795486;

WHEREAS, the Administrative Agent has agreed to terminate and release all of its interest in and to the Released Collateral; and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Administrative Agent hereby irrevocably terminates, releases and discharges all mortgages, liens, security interests and any other rights that are or may have been granted to the Administrative Agent in and to the Released Collateral.

This is a PARTIAL RELEASE only, and the lien and effect of the Security Instruments shall remain in full force and effect as to all property encumbered by the Security Instruments, other than with respect to the Released Collateral.
