WHEREAS, **Ebco Battery Co.**, a Georgia corporation, is the record owner of a certain trademarks and registrations including: “**ELECTRONA**”, Registration No. 942,672 registered September 12, 1972; “**ALWAYS STARTING SOMETHING**”, Registration No. 1,044,684 registered July 27, 1976; and “**LITTLE EBBY LOGO**”, Registration No. 1,050,528 registered October 19, 1976;

WHEREAS, on February 24, 1984, **Ebco Battery Co.**, a Georgia corporation, amended its articles of incorporation to change its name from **Ebco Battery Co.** to **Ebco Batteries, Inc.**, a certified copy of the amendment evidencing the change of name is attached hereto as Exhibit A;

WHEREAS, on February 20, 1984, **Ebco Battery Co.** was incorporated under the laws of the State of Georgia, a certified copy of the articles of incorporation are attached hereto as Exhibit B;

WHEREAS, on February 27, 1984, by a general bill of sale, **Ebco Batteries, Inc.** transferred all its assets of its business to **Ebco Battery Co.**, a Georgia corporation; and

WHEREAS, the aforementioned trademark registrations were included among the assets thus transferred; and

WHEREAS, the president of the **Ebco Batteries, Inc.** at the time of said sale of assets was **B. A. Waddell, Sr.**; and

WHEREAS, **Ebco Battery Co.** became the sole and entire successor to the business, assets, and goodwill of the **Ebco Batteries, Inc.**, including said marks together

with the goodwill of the business symbolized by the marks and the above-identified registrations thereof; and

WHEREAS, **Ebco Batteries, Inc.** now desires to enter into this Assignment Nunc Pro Tunc formalizing the prior transfer to **Ebco Battery Co.** of the said marks and associated goodwill, and the registrations identified above, in a form acceptable for recordation by the United States Patent & Trademark Office;

NOW, THEREFORE, in consideration of the foregoing and other good and valuable consideration the receipt and sufficiency of which are hereby acknowledged, **Ebco Batteries, Inc.** does assign, convey, and transfer unto **Ebco Battery Co.** the entire right, title and interest in and to said marks and said registrations thereof, together with the goodwill of the business symbolized by said marks. This Assignment is expressly made NUNC PRO TUNC, this Assignment to have the same legal force and effect as if executed on February 27, 1984.
