**ASSIGNMENT OF TRADEMARKS

**NOW, THEREFORE,** in consideration of the mutual covenants and agreements set forth herein, and for other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the parties hereto agree as follows:

Assignor hereby irrevocably conveys, transfers, assigns, and delivers to Assignee all of Assignor's right, title and interest of whatever kind in and to the Trademarks, as set forth on **Schedule 1** hereto, together with the goodwill of the business associated therewith.

Assignor further hereby agrees that Assignee shall have the right to record this instrument of assignment in the United States Patent and Trademark Office and any and all patent and trademark offices worldwide so as to establish Assignee as owner of record of the Trademarks.

Without limiting the foregoing, the rights assigned herein to the Trademark shall extend throughout the world, whether the Trademarks are registered or not and whether or not set forth on **Schedule 1** hereto.

Without limiting the foregoing, the rights assigned herein shall include any causes of action or claims that have occurred or will occur, in connection with any of the rights assigned herein.

Assignor further hereby revokes all previous powers of attorney related to the Trademarks as set forth on **Schedule 1** hereto and appoints Assignee, with full power of substitution and revocation vested in Assignee, to prepare and execute on Assignor's behalf, any documents necessary or required by the United States Patent and Trademark Office and any and all foreign patent and trademark offices worldwide in connection with and to demonstrate Assignor's consent to use, register, and/or attempt to register the Trademarks as set forth on **Schedule 1** hereto by Assignee and its successors and assigns.


