

The Assignor consents that a copy of this assignment shall be deemed a full legal and formal equivalent of any assignment, consent to file or like document which may be required in any country for any purpose and more particularly in proof of the right of the Assignee or nominee to claim any aforesaid benefit of the right of priority provided by the Madrid Protocol or by any convention which may henceforth be substituted for it.

The Assignor covenants with the Assignee, its successors, assigns and legal representatives, that the rights and property herein conveyed Assignment are free and clear of any encumbrance, and that I have full right to convey the same as here expressed.
