DECLARATION OF J. TUCKER BARR

1. My name is J. Tucker Barr. I am over twenty-one years of age and I make the following declaration based on my own personal knowledge. I am the attorney of record for Athlon Sports Communications, Inc. d/b/a Athlon Media Group (“Athlon”) with respect to the federal trademark registration for NUMBRIX, Reg. No. 3767787 (the “Mark”).

2. The registration for the Mark issued on March 30, 2010 to Advance Magazine Publishers, Inc. (“AMPI”). AMPI assigned the Mark to Parade Media Group, LLC (“PMG”) by a Trademark Assignment dated October 1, 2013 (the “AMPI/PMG Assignment”), which was recorded the same day. (See Reel/Frame: 5128/0880).

3. PMG assigned the Mark to Athlon by a Trademark Assignment Agreement dated February 9, 2015 (the “PMG/Athlon Assignment”), which was recorded on February 23, 2015. (See Reel/Frame: 5464/0370).

4. Athlon is the current owner of the Mark.

5. On August 7, 2015, counsel for Athlon filed a Section 8 & 15 Combined Affidavit for the Mark. The Combined Affidavit was refused in a Post-Registration Office Action dated September 9, 2015 (the “Office Action”). In the Office Action, the Trademark Specialist asserts that there is “an unexplained break in the chain of title that must be clarified.” Through subsequent correspondence, the Trademark Specialist further explained the Office Action and identified a typographical error in the AMPI/PMG Assignment.

6. The AMPI/PMG Assignment correctly identifies the Assignee as “Parade Media Group, LLC,” but later incorrectly describes this Delaware limited liability company as a “Delaware corporation.”

7. AMPI, the Assignor named in the AMPI/PMG Assignment, is not available to correct the original document or execute a new one.

8. Accordingly, the undersigned is submitting this Declaration pursuant to T.M.E.P. § 503.06(b) on behalf of Athlon to correct the typographical error identified by the Trademark Specialist.

9. The following are submitted with this Declaration: (1) a new complete cover sheet; (2) a copy of the originally recorded AMPI/PMG Assignment with the correction thereto initialed and dated by the undersigned (Exhibit 1); (3) the cover sheet and assignment used for the original recordation (Exhibit 2); and (4) the required fee.




