RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTERESTS IN INTELLECTUAL PROPERTY (this "Release") is made as of January 26, 2016 ("Effective Date"), by Silicon Valley Bank (the "Bank") in favor of The Allant Group, Inc., an Illinois corporation (the "Grantor"). Capitalized terms not defined herein shall have the meanings ascribed to such terms in the IP Security Agreement (as defined below).

WITNESSETH:

WHEREAS, Bank and Grantor are parties to that certain Loan and Security Agreement, dated as of March 18, 2013 (as amended, amended and restated, supplemented or otherwise modified from time to time) (the "Loan Agreement");

WHEREAS, pursuant to the Loan Agreement, that certain Intellectual Property Security Agreement, dated as of March 18, 2013 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "IP Security Agreement"), was (a) entered into by Grantor and Bank to record the security interest with respect to the Intellectual Property Collateral (as defined in the IP Security Agreement), including, without limitation, the trademarks set forth on Schedule A hereto, and (b) recorded with the United States Patent and Trademark Office on March 20, 2013, at Reel 004986, Frame 0444; and


WHEREAS, Grantor and Bank have agreed to a specific release of the security interest granted and recorded against the Intellectual Property Collateral.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Bank hereby (i) terminates the IP Security Agreement and releases and re-assigns to Grantor any and all liens, security interests, right, title and interest it may have in, to and under the Intellectual Property Collateral, including, without limitation, those items set forth on Schedule A hereto, together with the goodwill of the business symbolized thereby; (ii) agrees that it shall execute all other documents and do all other acts reasonably requested by Grantor to relinquish and effect the release of such rights to Grantor; and (iii) authorizes and requests that the United States Patent and Trademark Office note and record the release hereby given and any other filings necessary to evidence the release and termination of the Bank's rights under the IP Security Agreement with respect to the Intellectual Property Collateral.
