DECLARATION OF RYAN CIUCKI,
AS CHIEF FINANCIAL OFFICER OF ACTIVE SPORTS LIFESTYLE USA, LLC AND
ARS BRANDS, LLC

Ryan Ciucki, as Chief Financial Officer of Active Sports Lifestyle USA, LLC and ARS Brands, LLC, declares:

1. I am the Chief Financial Officer of Registrant, Active Sports Lifestyle USA, LLC, a Florida limited liability company ("Active Sports Lifestyle USA") and ARS Brands, LLC, a Delaware limited liability company ("ARS Brands") and am authorized to make this Declaration on behalf of both Active Sports Lifestyle USA and ARS Brands.
2. ARS Brands is the registrant and owner of the entire right, title and interest in and to said trademark registration, together with the goodwill of the business during December 13, 2005 – July 3, 2009, by assignment from Active Sports Lifestyle USA, its affiliate.
3. On July 3, 2009 a Trademark and License Security Agreement ("Security Agreement"), dated July 3, 2009 was recorded in the United States Patent and Trademark Office, Trademark Assignment Branch, Reel/Frame 004063/0475, granting a security interest


in and to said trademark registration to Merrill Lynch Commercial Finance Corp., (“Merrill Lynch”), a Delaware corporation, by Active Sports Lifestyle USA.

4. According to § 9-515 of the Uniform Commercial Code, any security interest granted to Merrill Lynch in said trademark registration lapsed in 2014, five years after the date of filing of the financing statement perfecting the interest granted pursuant to the Security Agreement.
5. Merrill Lynch is no longer an active or existing entity. Its successor in interest, Bank of America, N.A., has expressly authorized Active Sports Lifestyle USA and ARS Brands in writing to submit this corrective filing.
6. As Chief Financial Officer of Active Sports Lifestyle USA, and ARS Brands, I, Ryan Ciucki, hereby certify that a document suitable for recording in the United States Patent and Trademark Office for purposes of evidencing the release, relinquishment, discharge and termination of Merrill Lynch’s security interest in Registration Number 3,024,942, executed by an officer of Merrill Lynch is not attainable.
7. The current owner of said trademark registration is ARS Brands, and as Chief Financial Officer of ARS Brands, I, Ryan Ciucki, am authorized to make this filing on behalf of ARS Brands.
8. All statements made herein of my own knowledge are true and all statements made on information and beliefs are believed to be true; and further, these statements were made with the knowledge that willful false statements and the like so made are punishable by fine or imprisonment, or both, under Section 1001 of Title 18 of the
