Assignment of Trademarks

THIS ASSIGNMENT OF TRADEMARKS ("Agreement") is dated as of January 27, 2016.

WHEREAS, DICE CAREER SOLUTIONS, INC., a Delaware corporation, and eFinancialCareers Limited, an entity organized under the laws of the United Kingdom, (collectively, the "Assignor"), has adopted, acquired, used and is using in a substantially exclusive and continuous manner in connection with its operation of the Slashdot Media websites and related business the trademarks, service marks, trade names and domain names listed on Schedule 1 attached hereto and made a part hereof (the "Trademarks");

WHEREAS, SourceForge Media, LLC, a California limited liability company ("Assignee"), is desirous of acquiring all right, title and interest in and to said Trademarks; and

WHEREAS, pursuant to an ASSET PURCHASE AGREEMENT dated as of January 27, 2016 by and between Assignor and Assignee (the "Asset Purchase Agreement"), Assignor has agreed to transfer and assign the Trademarks to Assignee, who has agreed to acquire the Trademarks from Assignor,

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby irrevocably sells, assigns, transfers and delivers to Assignee, its successors and assigns, its entire right, title and interest, whether statutory or at common law, free and clear of all liens and encumbrances, in and to the Trademarks, and all registrations and applications for registration owned by Assignor worldwide, whether in the United States Patent Office ("PTO") or the equivalent thereof in any state of the United States or in any other country or pursuant to any international (Madrid Protocol, European Community or other) registry, as well as any trade dress, including logos, designs, Buyer names, business names, fictitious names and other business identifiers used by Assignor in the United States or any other country in connection with any of the Trademarks; all the goodwill and know-how of Assignor's business connected with the use of and symbolized by the Trademarks; all common law rights throughout the world acquired by Assignor in the Trademarks; all income, royalties, and payments now or hereafter accrued, due or payable in respect to the Trademarks; and all causes of action (either in law or equity) and the right to sue, counterclaim and recover for past, present and future infringement, dilution or misappropriation of the rights in the Trademarks, as well as all rights (registered or unregistered) corresponding thereto throughout the world (collectively, including the Trademarks, the "Trademark Assets"), on the terms set forth in the Asset Purchase Agreement, the intent hereof being to substitute Assignee in the place of Assignor.

Assignor further authorizes the Commissioner of Patents and Trademarks of the United States, whose duty it is to record trademark registrations, applications and title thereto, to record the Trademarks and title thereto as the property of Assignee, its successors, legal representatives and assigns, if applicable, in accordance with the terms of this Agreement.

Assignor further agrees to execute such further documents as may be reasonably required to record Assignee as the owner of the Trademarks and registrations and applications herein assigned, solely at the cost of Assignee.


This Agreement may be executed in several counterparts, each of which shall be deemed an original, but all of which together will constitute one and the same instrument. Counterparts of this Agreement (or applicable signature pages hereof) that are manually signed and delivered by facsimile transmission shall be deemed to constitute signed original counterparts hereof and shall bind the parties signing and delivering in such manner.


