RELEASE OF SECURITY INTEREST IN TRADEMARKS AND COPYRIGHTS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS AND COPYRIGHTS (this "Release") is made as of January 28, 2016 ("Effective Date") by and between Mongolian Management and Investment Company, L.L.C. ("Grantor") and Tankas Funding II, LLC ("Administrative Agent").

WHEREAS, Grantor entered into that certain Credit Agreement by and between Grantor, General Electric Capital Corporation ("GECC") and the other parties thereto, dated May 2, 2008 (the "Credit Agreement");

WHEREAS, in connection with the Credit Agreement, Grantor granted to GECC a lien on and security interest under certain intellectual property and entered into that certain IP Security Agreement, dated May 2, 2008 (the "IP Security Agreement") for the purpose of recording such security interest with respect to the trademarks and copyrights of Grantor, including those items set forth on Schedule A hereto (as further defined in the IP Security Agreement, the "IP Collateral") with the United States Patent and Trademark Office and the United States Copyright Office;

WHEREAS, GECC entered into that certain Assignment of Security Interests in Trademarks and Copyrights, dated February 27, 2015, to assign its interest in the liens and the security interests granted by the IP Security Agreement to the Administrative Agent, and such assignment was recorded with the United States Patent and Trademark Office on March 3, 2015, at Reel 5469, Frame 0861; and the United States Copyright Office on March 3, 2015; and

WHEREAS, Grantor has paid all of its outstanding indebtedness to the Administrative Agent.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby: (i) terminates the IP Security Agreement, (ii) terminates, cancels and releases any and all liens and security interests it has with respect to the IP Collateral, and (iii) re-assigns to Grantor any right, title and interest it may have in, to and under the IP Collateral to Grantor.

The Administrative Agent shall take all further actions, and provide to Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release.
