**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS** (this “Release”) is made as of January 5, 2016 (“Effective Date”) in favor of Checkers Drive-In Restaurants, Inc. and Official Burger of Tampa Bay, Inc. (together, “Guarantors”) by Wells Fargo Bank, National Association (the “Collateral Agent”).

**WHEREAS**, Guarantors entered into that certain Parity Lien Security Agreement by and between Guarantors, Collateral Agent and the other parties thereto dated November 16, 2012 (the “Parity Lien Security Agreement”);

**WHEREAS**, pursuant to the Parity Lien Security Agreement, Guarantors granted to the Collateral Agent a lien on and security interest in all of their right, title and interest in, to and under certain intellectual property and entered into those certain Trademark Security Agreements dated November 16, 2012 (the “Trademark Security Agreements”) for the purpose of recording such security interest with respect to the trademarks of Guarantors, including those items set forth on Schedule A hereto (as further defined in the Trademark Security Agreements, the “Trademark Collateral”) with the United States Patent and Trademark Office;

**WHEREAS**, the Trademark Security Agreements were recorded with the United States Patent and Trademark Office on November 26 , 2012, at Reel 4906, Frame 0402, and at Reel 4906, Frame 0570;

**WHEREAS**, Guarantors have paid all of their outstanding indebtedness to the Collateral Agent.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby: (i) terminates the Trademark Security Agreements, (ii) terminates, cancels and releases any and all security interests it has against the Trademark Collateral, and (iii) re-assigns to Guarantors any right, title and interest it may have in, to and under the Trademark Collateral to Guarantors, including all goodwill associated therewith.

The Collateral Agent shall, at Guarantors’ expense, take all further actions, and provide to Guarantors, their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Guarantors to more fully and effectively effectuate the purposes of this Release.

This Release shall be governed by and construed in accordance with the laws of the State of New York.
