RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release"), dated February 1, 2016 is made by **Silicon Valley Bank**, with an office at 3003 Tasman Drive, Santa Clara, California 95054 ("Assignor"), in favor of **Interactive Achievement, LLC**, a Delaware limited liability company, with an office at 601 Campbell Avenue SW, Roanoke, Virginia 24016 ("Debtor"). Capitalized terms used but not defined herein shall have the meaning given to them in the Security Agreement (as defined below).

WHEREAS, pursuant to that certain Intellectual Property Security Agreement by and between Assignor and Debtor, dated February 17, 2015, as the same may from time to time have been amended, restated, or otherwise modified (the "Security Agreement"), Debtor granted to Assignor a continuing security interest in all of Debtor's right, title, and interest in and to certain intellectual property assets, including, without limitation, the United States trademark registrations and applications set forth on Schedule A attached hereto (the "Trademarks") and the United States copyright registrations set forth on Schedule B attached hereto (the "Copyrights");

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on February 11, 2015, at Reel/Frame 5458/0629; and

WHEREAS, any and all secured obligations as defined by the Security Agreement have been satisfied, and the requirements of the Security Agreement for discharge of the liens in the Intellectual Property Collateral have been satisfied.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby terminates the Security Agreement, and hereby terminates, cancels, and releases any and all security interests it has against the Intellectual Property Collateral thereunder, including, but not limited to the Trademarks and Copyrights, without any representation, warranty, or recourse whatsoever, effective as of the date set forth above.

The parties hereto agree that, at any time and from time to time upon written request of the other party, each party will execute and deliver such documents and do such further acts as may be reasonably requested by the other party in order to effect the purpose of this Release.


