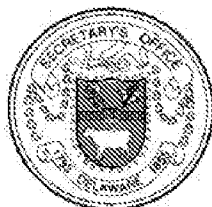

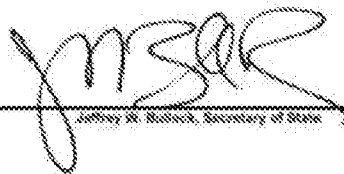

"1. The name of the corporation (hereinafter called the "**Corporation**") is Klein Marine Systems, Inc."

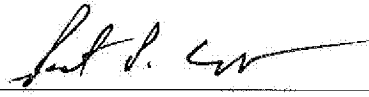
SECOND: The foregoing Amendment has been duly adopted in accordance with the requirements of Section 242 of the General Corporation Law of the State of Delaware.
