The undersigned person, acting as the organizer of a limited liability company under the Texas Business Organizations Code, does hereby submit the following Certificate of Formation for such limited liability company:


1. The filing entity being formed is a limited liability company. The name of the entity is Nursefinders, LLC.



**CERTIFICATE OF CONVERSION**

**NURSEFINDERS, INC.**  
(a Texas corporation)

**CONVERTING INTO**

**NURSEFINDERS, LLC**  
(a Texas limited liability company)

Pursuant to the provisions of Sections 10.154 and 10.155 of the Texas Business Organizations Code (the "TBOC"), the undersigned converting entity certifies the following Certificate of Conversion adopted for the purpose of effecting a conversion in accordance with the provisions of the TBOC.

**FIRST:** The name of the converting entity will be Nursefinders, Inc. (the "Converting Entity"). The Converting Entity is a Texas corporation organized pursuant to the Texas Business Corporation Act, as amended (the "Act"). The Converting Entity was formed effective January 29, 1975.

**SECOND:** The name of the converted entity is Nursefinders, LLC (the "Converted Entity"). The Converted Entity will be organized as a Texas limited liability company pursuant to the TBOC.

**THIRD:** A Plan of Conversion (the "Plan of Conversion") was duly authorized and approved by all action required by the laws of the State of Texas, including the TBOC, and by the Converting Entity's constituent documents.

**FOURTH:** The address of the principal place of business of the Converting Entity is 524 E. Lamar Blvd., Suite 300, Arlington, Texas 76011. An executed Plan of Conversion is on file at such address. The address of the principal place of business of the Converted Entity will be 524 E. Lamar Blvd., Suite 300, Arlington, Texas 76011. An executed Plan of Conversion will be on file, from and after the conversion, at such address.

**FIFTH:** A copy of the Plan of Conversion will be furnished by the Converting Entity, prior to the conversion, or the Converted Entity, from and after the conversion, on written request and without cost, to any shareholder of the Converting Entity or any member of the Converted Entity.

**SIXTH:** The total number of shares outstanding of the Converting Entity is 20, and the total number of shares of the Converting Entity voting in favor of the conversion is 20.

**SEVENTH:** In lieu of receipt of a certificate of account status from the Texas Comptroller of Public Accounts, the Converted Entity will be responsible for the payment of all franchise taxes and fees related thereto owed by the Converting Entity and the Converted Entity will be obligated to pay such franchise taxes and fees if the same are not timely paid.

**SEVENTH:** The conversion shall become effective on December 23, 2010 at 2:01 am Central Standard Time.
