The undersigned does hereby certify on behalf of InsideVault Inc. (the "Corporation"), a corporation organized and existing under the General Corporation Law of the State of Delaware, as follows:

1. That he is the duly elected and acting President of the Corporation.
2. That the Certificate of Incorporation of the Corporation was originally filed with the Secretary of State of the State of Delaware on April 15, 2011.
3. Pursuant to Section 242 of the Delaware General Corporation Law (the "DGCL"), this Certificate of Amendment to the Corporation's Amended and Restated Certificate of Incorporation (the "Restated Certificate") amends certain provisions of the Restated Certificate.
4. The terms and provisions of this Certificate of Amendment to the Restated Certificate have been duly approved by written consent of the required number of shares of outstanding stock of the Corporation pursuant to Subsection 228(a) of the DGCL.
5. Article I of the Restated Certificate is hereby amended to read in its entirety as follows:

"The name of the Corporation is QuanticMind, Inc."

6. Article V, Section 1(d) of the Restated Certificate is hereby amended to read in its entirety as follows:

"Corporation" means QuanticMind, Inc."

IN WITNESS WHEREOF, this Certificate of Amendment to the Restated Certificate, which amends certain provisions of the Restated Certificate, having been duly adopted in accordance with Section 242 of the DGCL, has been duly executed by its President this 6th day of October, 2015.
