AND FURTHER, PEI does also assign unto SUMMIT nunc pro tunc any rights of registration, continuation or renewal and any and all rights of recovery for infringement thereof of the mark;

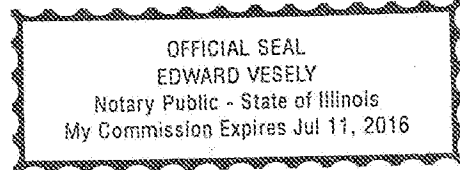
