TRADEMARK ASSIGNMENT AGREEMENT



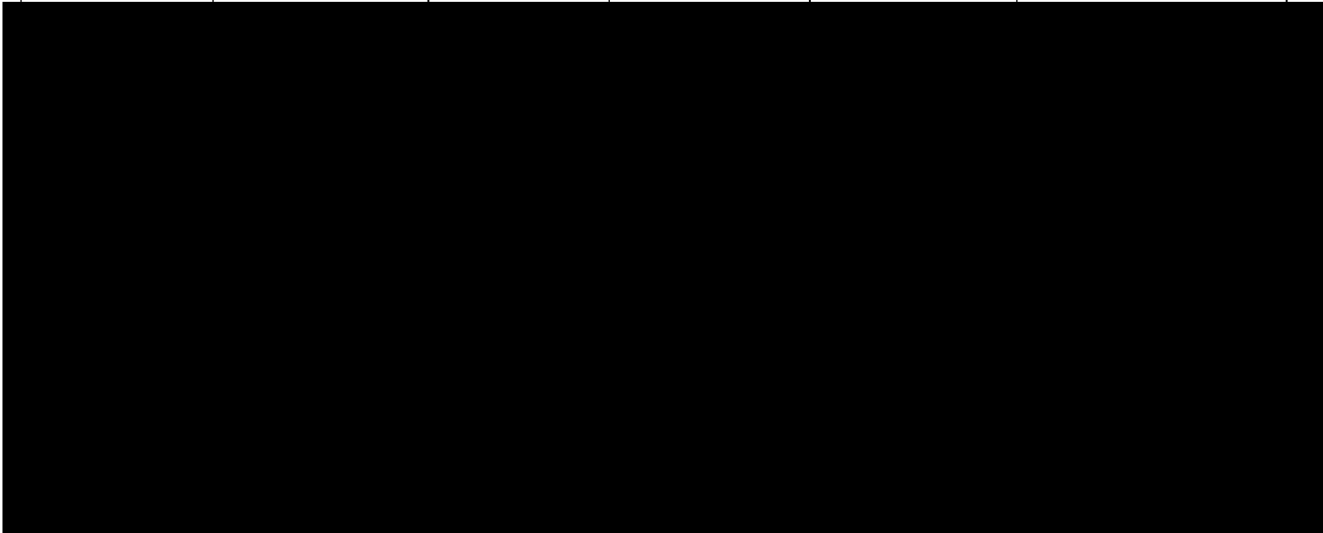
