RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE dated as of May 30, 2014 (this "Release") is made by Silicon Valley Bank (the "Bank"), under that certain Intellectual Property Security Agreement dated as of the Effective Date (as defined in that certain Loan and Security Agreement by and between Secured Party and Aldera Holdings, Inc., a Delaware corporation, formerly known as Healthation, Inc. ("Debtor") dated as of the Effective Date) (as amended, restated or otherwise modified from time to time, the "Security Agreement")) by and between Secured Party and Debtor and recorded in the records of the United States Patent and Trademark Office at Trademark Reel 4996, Frame 0732.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Secured Party does hereby release and terminate its security interest in the Trademarks, and discharges, quit claims and relinquishes unto Debtor (in each case without recourse and without any representation or warranty) any and all right, title and interest it has in and to the Trademarks under the Security Agreement.
