TERMINATION OF TRADEMARK SECURITY AGREEMENT

This Termination of Trademark Security Agreement (this "Termination"), dated as of February 3, 2016, is executed by LLOYDS BANK PLC ("Secured Party"), in favor of DALER-ROWNEY USA LIMITED, a company incorporated in England and Wales with company number 2195762 (the "Grantor").

RECITALS

WHEREAS, the Grantor and the Secured Party entered into that certain Trademark Security Agreement (the "Trademark Security Agreement"), dated as of July 21, 2015;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on July 27, 2015 at Reel 5585, Frame 0558;

WHEREAS, pursuant to the Trademark Security Agreement, the Grantor granted to Secured Party a security interest in certain "Collateral" (as defined in the Trademark Security Agreement) including certain registered trademarks; and

WHEREAS, the Trademark Security Agreement has been terminated pursuant to a certain Deed of Release dated 3 February, 2016 between Renior Midco Limited (the "Parent") and Secured Party.

NOW, THEREFORE, Secured Party agrees as follows:


1. Secured Party is executing and delivering this Termination as further evidence of the termination of the Trademark Security Agreement.
2. Secured Party claims no right, title or interest whatsoever in or to any of the "Collateral" described in the Trademark Security Agreement, and, accordingly, Secured Party expressly terminates, releases, and discharges any and all security interests that it has pursuant to the Trademark Security Agreement in any and all right, title and interest of the Grantor and reassigns to the Grantor any and all right title and interest that it may have in, to and under (i) the trademark listed on Exhibit A hereto and (ii) all products and proceeds of the foregoing, including any claim by the Grantor against third parties for past, present or future infringement of the foregoing.
3. This Termination is governed by the laws set forth in Section 12 (Governing Law) of the Trademark Security Agreement.
