**NOTICE OF RELEASE OF SECURITY INTEREST  
IN TRADEMARKS**

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, the Administrative Agent hereby relinquishes, releases and discharges its security interest in all right, title and interest in and to the Released Trademarks, and hereby reassigns, grants and conveys to Grantor any and all of the Administrative Agent's right, title and interest in and to such Released Trademarks. This Notice of Release of Security Interest in Trademarks is applicable only with respect to the Released Trademarks and is not applicable to any other collateral assigned or granted under the IP Security Agreement (the "Retained Collateral"). The Administrative Agent retains all security interests, liens, rights, titles and interests pledged and granted to the Administrative Agent under the IP Security Agreement with respect to all such Retained Collateral, and the Administrative Agent's security interest, liens, rights, titles and interests in such Retained Collateral shall not be impaired, interrupted or otherwise modified in any respect by this Notice of Release of Security Interest in Trademarks.
