

ASSIGNMENT OF INTELLECTUAL PROPERTY ASSETS AGREEMENT

WHEREAS, Assignor desires to execute this Agreement to complete the assignment of the Intellectual Property Assets to Assignee, and Assignee desires to execute this Agreement to accept such assignment and assume the Intellectual Property Assets.

NOW THEREFORE, in consideration of the premises and other good and valuable consideration to it in hand paid, the receipt and sufficiency of which is hereby acknowledged, and further to complete the action required of Assignor and Assignee under the Restructuring Agreement, the parties, intending to be legally bound, the parties hereby agree as follows:

- **A.** <u>Assignment.</u> Assignor hereby irrevocably transfers, assigns, conveys and delivers to Assignee, its successors and assigns, in perpetuity, all rights (whether now known or hereinafter invented), titles, and interests, including any renewals or extensions thereto, in, to and under those Intellectual Property Assets of Assignor that are listed in <u>Schedule I</u>.
- **B.** Acknowledgment and Assumption. Assignee hereby accepts and acquires from Assignor the Intellectual Property Assets assigned in and by this Agreement as of the Effective Date.
- **C.** <u>Further Actions.</u> Each of the parties hereto covenants and agrees, at its own expense, to execute and deliver, at the request of the other party hereto, such further instruments of transfer and assignment and to take such other action as such other party may reasonably

- 5. This Agreement shall be construed in accordance with, and shall be governed by, the laws of the State of New York without regards to conflict of law principles.
