**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This RELEASE (this “Trademark Release”) is made as of February 5, 2016 from **MORGAN STANLEY SENIOR FUNDING, INC.**, as Collateral Agent, (as defined below) for the Secured Parties (as defined in the Credit Agreement referred to below), to **PIEDMONT HAWTHORNE AVIATION, L.L.C.**, (the “Grantor”).

WHEREAS **PIEDMONT HAWTHORNE AVIATION, L.L.C.**, a Delaware limited liability company with principal offices at 1500 CityWest Blvd., Suite 600, Houston, Texas 77042 (“Grantor”), entered into a certain first lien intellectual property security agreement supplement dated August 27, 2014 (the “First Lien IP Security Agreement Supplement”) with **MORGAN STANLEY SENIOR FUNDING, INC.**, a Delaware corporation, notice of which was recorded on August 27, 2014 at the United States Patent and Trademark Office at Reel 5352, Frame 0470, and with a corrective filing recorded on September 4, 2014 at the United States Patent and Trademark Office at Reel 5357, Frame 0719.

WHEREAS, Grantor granted the Collateral Agent, under the terms of the First Lien IP Security Agreement Supplement, a continuing security interest (the “Security Interest”) in favor of the Collateral Agent, in and to certain of Grantor’s intellectual property, including without limitation the trademarks listed in **Schedule A** (collectively, the “Trademarks”) and all of the goodwill of the business connected with the use of, and symbolized by the Trademarks.

WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all such Trademarks as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges any and all of its interest in the intellectual property of the Grantor, including the Trademarks, and all of the goodwill of the business connected with the use of, and symbolized by the Trademarks, and assigns, transfers and conveys to Grantor any interest in such intellectual property, including the Security Interest.
