**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

This RELEASE (this “Trademark Release”) is made as of February 5, 2016 from **MORGAN STANLEY SENIOR FUNDING, INC.**, as Collateral Agent, (as defined below) for the Secured Parties (as defined in the Credit Agreement referred to below), to **LANDMARK FBO, LLC and LANDMARK AVIATION WAUKEGAN, LLC**, (collectively, the “Grantors”).

WHEREAS **LANDMARK FBO, LLC**, a Delaware limited liability company with principal offices at 1500 CityWest Blvd., Suite 600, Houston, Texas 77042, and **LANDMARK AVIATION WAUKEGAN, LLC**, a Delaware limited liability company with principal offices at 1500 CityWest Blvd., Suite 600, Houston, Texas 77042 (collectively, the “Grantors”), entered into a certain Second lien intellectual property security agreement dated October 25, 2012 (the “Second Lien IP Security Agreement”) with **MORGAN STANLEY SENIOR FUNDING, INC.**, a Delaware corporation, notice of which was recorded on October 26, 2012 at the United States Patent and Trademark Office at Reel 4889, Frame 0382, and at Reel 4889, Frame 0393.

WHEREAS, Grantors granted the Collateral Agent, under the terms of the Second Lien IP Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Collateral Agent, in and to certain of Grantors’ intellectual property, including without limitation the trademarks listed in **Schedule A** (collectively, the “Trademarks”) and all of the goodwill of the business connected with the use of, and symbolized by the Trademarks.

WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all such Trademarks as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges any and all of its interest in the intellectual property of the Grantors, including the Trademarks, and all of the goodwill of the business connected with the use of, and symbolized by the Trademarks, and assigns, transfers and conveys to Grantors any interest in such intellectual property, including the Security Interest.
