TRADEMARK ASSIGNMENT

WHEREAS, Rackspace US, Inc. ("Assignor"), a corporation organized under the laws of the State of Delaware and having an address at 1 Fanatical Place, City of Windcrest, San



Antonio, Texas 78218, owns trademark rights in the marks JUNGLE DISK and  (the "Jungle Disk Logo") (collectively, the "Marks") used in connection with "downloadable computer software for use in storing, backing up, and archiving electronic data files, documents, images and other digital content" and "computer services, namely, providing electronic data storage, backup and archiving services for electronic data files, documents, images and other digital content" (collectively, the "Goods and Services").


WHEREAS, the Registration and the Marks, along with Assignor's rights, including common-law rights and the goodwill arising from Assignor's use of the Marks in connection with the Goods and Services, are collectively referred to herein as the "Trademark Property."

WHEREAS, Porthcawl Jackson, LLC ("Assignee"), a limited liability corporation organized under the laws of the State of Delaware and having an address at 110 E. Houston St., Suite 270, San Antonio, Texas 78205, desires to acquire all of Assignor's right, title, and interest in the Trademark Property.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns to Assignee all of Assignor's right, title, and interest in and to the Trademark Property, and the right to sue and collect damages against third parties for all instances of past and future trademark infringement, unfair competition, trademark dilution, and other violations of the Lanham Act and analogous state laws, with respect to the Trademark Property. Assignor shall have no remaining rights whatsoever in the Trademark Property.
