## TERMINATION OF TRADEMARK SECURITY AGREEMENT

This TERMINATION OF TRADEMARK SECURITY AGREEMENT, dated as of February 8, 2016, is made by SPCP Group, LLC and SummitBridge National Investments LLC (collectively, the "Secured Parties").

**WHEREAS**, SourceLink Industries, Inc. (the "Grantor") granted to Fleet National Bank ("Fleet") a security interest in certain trademarks listed on Exhibit A hereto (the "Trademarks"), pursuant to that certain Trademark Security Agreement dated of May 20, 2004, by and between the Grantor and Fleet (the "Security Agreement");

**WHEREAS**, such security interest granted to the Secured Parties was recorded in the United States Patent and Trademark Office ("USPTO") on June 2, 2004, at Reel 002863 and Frame 0407;

**NOW, THEREFORE**, for valuable consideration, the Secured Parties hereby terminate and release all liens and security interests in the Trademarks pursuant to the Security Agreement.
