RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

WHEREAS, the Grantee has released its security interest in all of the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantee hereby terminates and releases all of its security interests in and liens on all of the Trademark Collateral granted in the First Security Agreement and Second Security Agreement and the undersigned hereby acknowledges and agrees that it has no further interests in such Trademark Collateral and that such First Security Agreement and Second Security Agreement are terminated and of no further force and effect.
