### RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of January 15, 2016 ("Effective Date") by WELLS FARGO BANK, NATIONAL ASSOCIATION ("Grantee"), in favor of POWER PARTNERS, INC., a Georgia corporation ("Grantor").

WHEREAS, pursuant to the terms and conditions of that certain Patent and Trademark Security Agreement, dated as of May 26, 2011 (the "Security Agreement"), Grantor assigned, transferred and conveyed to Grantee, and granted to Grantee, a security interest in all of Grantor's right, title and interest in and to the Trademarks (as defined in the Security Agreement, the "Trademark Collateral");

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on June 1, 2011 at Reel 4552, Frame 0177 and on April 27, 2012 at Reel 4766, Frame 0129;

WHEREAS, Grantee has consented to the release of the Lien on all of the Trademark Collateral, including but not limited to the trademarks listed on Schedule 1 hereto (collectively, the "Released IP Collateral");

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby covenants and agrees as follows:


Grantee's mortgage, pledge, and hypothecation and Lien on and security interest in the Released IP Collateral is hereby terminated and released.

To the extent Grantee retains any such interest, Grantee hereby assigns, transfers and conveys to Grantor, all of Grantee's right, title and interest, now owned or hereinafter acquired, that it may have whether by assignment or otherwise, in and to any mortgage and continuing security interest and collateral assignment in the Released IP Collateral. Such assignment, transfer and conveyance by Grantee is made without any representation or warranty (express or implied) by Grantee.



