TRADEMARK ASSIGNMENT

**WHEREAS**, Vans, Inc., a Delaware corporation (“**ASSIGNOR**”), owns certain trademarks and/or service marks, and applications and/or registrations for such marks, as listed in Exhibit A attached hereto and incorporated herein by this reference (“**MARKS**”);

**WHEREAS** Dye Precision, Inc., a California corporation (“**ASSIGNEE**”), desires to acquire all of the right, title and interest of **ASSIGNOR** in, to and under the **MARKS**, together with the goodwill of the business symbolized by the **MARKS**; and

**WHEREAS**, **ASSIGNOR** and **ASSIGNEE** have entered into a certain Asset Purchase Agreement dated November 8, 2012 (the “**Purchase Agreement**”), selling, assigning, conveying, and transferring, among other things, all right, title and interest in and to the **MARKS** and in and to the registrations and/or applications for same from **ASSIGNOR** to **ASSIGNEE** and **ASSIGNOR** has agreed to execute and deliver this Trademark Assignment, for recording with governmental authorities in the United States including, but not limited to, the US Patent and Trademark Office.

**NOW, THEREFORE**, in consideration of the sum of One dollar (\$1.00) and other good and valuable consideration paid by **ASSIGNEE** to **ASSIGNOR** as set forth in the Purchase Agreement, the receipt and sufficiency of which hereby is acknowledged, **ASSIGNOR** does hereby irrevocably sell, assign, transfer and convey unto **ASSIGNEE** all of **ASSIGNOR**’S right, title and interest in and to the **MARKS**, and to the applications and/or registrations for the **MARKS** (and the right to apply for any of the foregoing), the right to renew the registrations, together with the goodwill of the business symbolized by the **MARKS** and the portion of the business of the **ASSIGNOR** to which the **MARKS** pertain; all rights to causes of action and remedies related thereto (including, without limitation, the right to sue for past, present or future infringement, misappropriation or violation of rights related to the foregoing); and any and all other rights and interests arising out of, in connection with or in relation to the **MARKS**.

**ASSIGNOR** authorizes the Commissioner of Trademarks of the United States and other empowered officials of the United States Patent and Trademark Office to record and register this Trademark Assignment upon request by **ASSIGNEE** and to record the transfer of the registrations and/or applications for registration of the **MARKS**, which such official has the authority to record, to **ASSIGNEE** as assignee of **ASSIGNOR**’S entire right, title and interest therein. **ASSIGNOR** shall take such steps and actions following the date hereof, including the execution of any documents, files, registrations, or other similar items, to ensure that the **MARKS** registered in the United States are properly assigned to **ASSIGNEE**, or any assignee or successor thereto.

This Trademark Assignment may be executed in counterparts, each of which shall be deemed an original, but all of which together shall be deemed to be one and the same agreement. A signed copy of this Trademark Assignment delivered by facsimile, e-mail or other means of electronic transmission shall be deemed to have the same legal effect as delivery of an original signed copy of this Trademark Assignment. This Trademark Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.

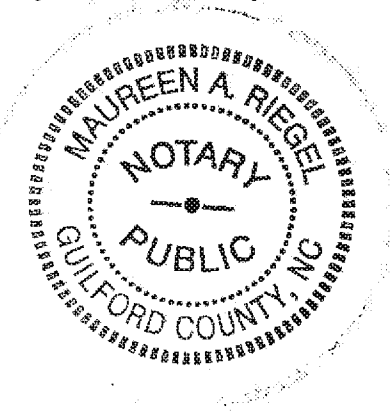
