
In accordance with Section 351.409 of The General and Corporation Business Law of Missouri (the "MGCBL"), ABI Document Support Services Inc., a Missouri corporation, **DOES HEREBY CERTIFY THAT:**

- First:** The name of the converting entity is ABI Document Support Services Inc., a Missouri corporation (the "Corporation"). The Corporation was organized in the State of Missouri under the name "EDCO Microfilming, Inc." The articles of incorporation of the Corporation were subsequently amended to change its name as follows: (a) to "EDCO Group, Inc." effective December 31, 2001, (b) to "ABI DOCUMENT SUPPORT SERVICES INC." effective May 1, 2014, and (c) "ABI Document Support Services Inc. on May 5, 2014."
- Second:** The original articles of incorporation of the Corporation were filed with the Secretary of State of the State of Missouri on August 14, 1961.
- Third:** The name of the converted entity is ABI Document Support Services Inc., a Delaware for-profit corporation, effective as of February 2nd, 2016.
- Fourth:** The conversion has been approved by the board of directors and adopted by the sole shareholder of the Corporation by unanimous written consent on or prior to the date hereof in accordance with Section 351.409 of the MGCBL.
- Fifth:** The converted entity agrees that it may be served with process in the State of Missouri in any action, suit or proceeding for enforcement of any obligation of the Corporation arising while it was a corporation of the State of Missouri, and the converted entity hereby irrevocable appoints the Secretary of State of Missouri as its agent to accept service of process in any such action, suit or proceeding.
