SkyrCo, Inc. (the “Corporation”), a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the “General Corporation Law”),

DOES HEREBY CERTIFY:

1. That the Board of Directors of the Corporation duly adopted resolutions by unanimous written consent proposing to amend the Amended and Restated Certificate of Incorporation of the Corporation (the “Certificate of Incorporation”) as follows:

RESOLVED: That the Board of Directors recommends and deems it advisable and in the best interests of the Corporation that the Amended and Restated Certificate of Incorporation of the Corporation be amended by deleting Article FIRST thereof in its entirety and substituting for said Article FIRST a new Article FIRST (the “Charter Amendment”), as follows:

“FIRST: The name of the corporation is Icelandic Provisions, Inc. (the “Corporation”).”

RESOLVED: That the officers of the Corporation be, and they hereby are, and each of them acting singly hereby is, authorized and directed to execute, deliver and file a Certificate of Amendment setting forth the Charter Amendment on behalf of the Corporation with the Secretary of State of the State of Delaware, any such officer’s approval to be conclusively evidenced by the execution and delivery of such Certificate of Amendment.

2. That this Certificate of Amendment, which amends the provisions of the Certificate of Incorporation, has been duly adopted in accordance with Section 242 of the General Corporation Law.
