TRADEMARK ASSIGNMENT

This **TRADEMARK ASSIGNMENT** (the "Assignment"), dated as of February 4, 2016, is by and between Tektronix Texas, LLC, a Delaware limited liability company ("Assignor") and Tektronix, Inc., an Oregon corporation ("Assignee") (each, a "Party" and collectively, the "Parties"). All capitalized terms used, but not defined herein, shall have the meanings ascribed to such terms in the Contribution Agreement or Separation and Distribution Agreement (each as defined herein below).

WHEREAS, pursuant to that certain Separation and Distribution Agreement by and between Danaher Corporation ("Danaher") and Potomac Holding LLC ("Newco"), dated as of October 12, 2014 (the "Separation and Distribution Agreement"), Danaher agreed to assign to Newco or one or more Newco Subs the Communications Assets and all of Danaher's and its applicable Subsidiaries' (including Assignor's) right, title and interest in, to and under the Communications Assets;

WHEREAS, pursuant to that certain Contribution Agreement between Assignor and Assignee, dated as of June 26, 2015 (the "Contribution Agreement"), Assignee contributed to Assignor, and Assignor accepted, all of the Assets, including all of Assignee's right, title, and interest in and to the trademark registrations set forth on Schedule A thereto;

WHEREAS, the assignment of the trademarks transferred by Assignee to Assignor pursuant to the Contribution Agreement was effected by a Trademark Assignment between the Parties dated as of August 13, 2015 (the "Trademark Assignment Agreement"), which was recorded with the United States Patent and Trademark Office on August 14, 2015 at Reel/Frame 5600/0179;

WHEREAS, the Parties agree that the trademark registration set forth on Schedule A hereto (the "Assigned Mark") was included in the Communications Assets under the Separation and Distribution Agreement in error and therefore was erroneously included in the Trademark Assignment Agreement; and

WHEREAS, the Parties now seek to enter into this Assignment to re-assign the Assigned Mark to Assignee in order to correct such error, and hereby confirm and evidence the conveyance, assignment, and transfer to Assignee of all of Assignor's right, title, and interest in and to the Assigned Mark.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties agree as follows:

1. Conveyance. Assignor does hereby convey, assign and transfer to Assignee all of Assignor's right, title and interest in and to (i) the Assigned Mark, together with the goodwill symbolized thereby and (ii) all benefits, privileges, causes of action, common law

rights, and remedies relating thereto throughout the world, including, without limitation, all of Assignor's rights to: (a) apply for and maintain all registrations, renewals and/or extensions thereof, (b) bring actions and recover damages for past, present and future infringement or other violation thereof and (c) grant licenses or other interests therein.

2. Recordation. Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks and any other applicable governmental entity or registrar (including any applicable foreign or international office or registrar), to record Assignee as the owner of the Assigned Mark, and to issue the Assigned Mark to Assignee, as assignee of Assignor's entire right, title and interest in, to, and under the same. Assignee shall have the right to record this Assignment with all applicable governmental authorities and registrars so as to perfect its ownership of the Assigned Mark.

3. Further Assurances. Assignor shall provide Assignee, its successors, assigns or other legal representatives, reasonable cooperation and assistance at Assignee's request and expense (including the execution and delivery of any and all affidavits, declarations, oaths, exhibits, assignments, powers of attorney or other documentation as may be reasonably required) as are reasonably requested by Assignee to effect, register, or maintain the rights assigned herein, including: (a) the preparation and prosecution by Assignee of any applications or registrations assigned herein; and (b) the prosecution or defense by Assignee of any interference, opposition, reexamination, reissue, infringement or other proceedings that may arise in connection with any of the rights assigned herein, including, but not limited to, testifying as to the fact of the assignment of rights hereunder.

4. No Modification. Nothing contained in this Assignment is intended to or shall be deemed to modify, alter, amend or otherwise change any of the rights or obligations of Assignor and Assignee and their respective Affiliates under the Contribution Agreement or the Separation and Distribution Agreement, other than to correct the erroneous assignment of the Assigned Mark.

5. Successors and Assigns. This Assignment shall inure to the benefit of and be binding upon the Parties and their respective successors and permitted assigns.

6. Counterparts. This Assignment may be signed in any number of counterparts, each of which shall be an original, with the same effect as if the signatures thereto and hereto were upon the same instrument. This Assignment shall become effective when each Party shall have received a counterpart hereof signed by the other Party. For the convenience of the Parties, any number of counterparts hereof may be executed, each such executed counterpart shall be deemed an original and all such counterparts together shall constitute one and the same instrument.

7. Descriptive Headings. The descriptive headings herein are inserted for convenience of reference only and are not intended to be part of or to affect the meaning or interpretation of this Agreement.

8. Governing Law. This Assignment shall be governed by and construed in accordance with the laws of the State of Delaware, regardless of the laws that might otherwise govern under applicable principles of conflicts of laws thereof, and any disputes regarding or arising out of this Assignment will be subject to the exclusive jurisdiction of the courts located in the State of Delaware.
