## **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release") is made this 23rd day of December, 2015, by BROOKSIDE MEZZANINE FUND III, L.P., as Agent (together with its successors and assigns, "*Secured Party*").

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party hereby irrevocably and forever releases and terminates its security interest in and to the IP Collateral arising thereunder including, without limitation, the intellectual property described in Schedules A, B, and C hereto. Further, Secured Party understands and agrees that this Release may be recorded by or for Grantor with the United States Patent and Trademark Office and any other similar office or agency throughout the world. Secured Party also agrees to execute any other documents and take any further action reasonably necessary in any jurisdiction that Grantor may reasonably require to effect the intent and purpose of this Release.

This Release shall be governed by and construed in accordance with the laws of the State of New York without regard to conflicts of law principles.


