**RELEASE AND TERMINATION  
OF SECURITY INTEREST IN U.S. TRADEMARKS AND U.S. PATENTS**

This **RELEASE AND TERMINATION OF SECURITY INTEREST IN U.S. TRADEMARKS AND U.S. PATENTS** (“Notice of Release”), dated as of February 11, 2016, is made by **CAPITAL ONE BUSINESS CREDIT CORPORATION** (*as successor in interest of Capital One Leverage Finance Corp.*) and **CAPITAL ONE, NATIONAL ASSOCIATION** (*as assignee of Capital One Business Credit Corporation*), each in its capacity as Agent (individually and collectively, the “Agent”) for the Secured Parties under that certain Amended and Restated Loan and Security Agreement dated as of August 13, 2014 (as amended, the “Loan Agreement”). Capitalized terms used herein without definition shall have the meanings assigned to them in the Loan Agreement.

**WHEREAS**, as security for the Obligations of NATIONWIDE INDUSTRIES, INC., a Florida corporation (“Nationwide”) under the Loan Agreement, Nationwide entered into:

(a) that certain Trademark Security Agreement dated as of October 25, 2010 (the “2010 Security Agreement”), whereby Nationwide and the other Grantors party thereto granted to the Agent a lien on and security interest in all of its right, title and interest in, in to and under all U.S. Trademarks (as defined in the 2012 Trademark Security Agreement), including, without limitation, each trademark registration and application listed on Schedule I attached hereto and incorporated herein (the “2010 Trademarks”), which was recorded in the records of the Trademark Assignment Division of the U.S. Patent and Trademark Office on October 26, 2010 at Reel 004304; Frame 0009;

(b) that certain Trademark Security Agreement dated as of December 19, 2012 (the “2012 Trademark Security Agreement”), whereby Nationwide and the other Grantors party thereto granted to the Agent a lien on and security interest in all of its right, title and interest in, in to and under all U.S. Trademarks (as defined in the 2012 Trademark Security Agreement), including, without limitation, each trademark registration and application listed on Schedule II attached hereto and incorporated herein (the “2012 Trademarks” and together with the 2010 Trademarks, the “Nationwide Trademark Collateral”), which was recorded in the records of the Trademark Assignment Division of the U.S. Patent and Trademark Office on December 27, 2012 at Reel 4929; Frame 0903; and

(c) that certain Patent Security Agreement dated as of December 19, 2012 (the “Patent Security Agreement”), whereby Nationwide and the other Grantors party thereto granted to the Agent a lien on and security interest in all of its right, title and interest in, to and under all U.S. Patents (as defined in the Patent Security Agreement), including, without limitation, each patent registration and application listed on Schedule III attached hereto and incorporated herein (the “Nationwide Patent Collateral”), which was recorded in the records of the Patent Assignment Division of the U.S. Patent and Trademark Office on December 27, 2012 at Reel 029548; Frame 0526;




