Pursuant to the Delaware Corporation Law, the Amended and Restated Certificate of Incorporation of Nipro Diagnostics, Inc., a Delaware Corporation (the "Corporation"), is hereby amended as follows:

FIRST: Article First of the Amended and Restated Certificate of Corporation is hereby amended and restated to read as follows:

"FIRST: The name of the corporation is Trividia Health, Inc. (hereinafter called the "Corporation")."
