

On or about June 26, 2015, a corrective assignment was also filed, to change the misspelled "Graden" above to "Garden." This was recorded at Reel/Frame 5562/0912. This was also inadvertent, having been applied to a prior assignment that lacked a chain of title. The assignment records should be changed to reflect the ownership in the original assignee, Harvest Power, Inc.
