The undersigned being hereby warned that willful false statements and the like so made are punishable by fine or imprisonment, or both, under 18 U.S.C. 1001, and that such willful false statements may jeopardize the validity of the registration, declares that:

1. I am the attorney for Aerin Medical Inc., the owner of the subject registration (the “Registrant”) and am properly authorized to execute this declaration.

2. The applicant of the subject registration was listed as “Aerin Medical, Inc.” in the original application filing. The true name of the owner of the original application and the subject registration is “Aerin Medical Inc.” (without comma). This discrepancy is due to a good faith error made in the original application form, which omitted the comma in the owner name.


3. In an attempt to correct this error, an employee of Registrant filed a Change of Name against the subject registration with the United States Patent Office. The Change of Name was recorded at Reel/Frame 5662/0398 on November 6, 2015 and changed the name of the Registrant from “Aerin Medical, Inc.” to “Aerin Medical.” Attached as Exhibit A is the cover sheet for this Change of Name filing. This Change of Name was improper and was not authorized by the Registrant, as no Change of Name has occurred.

4. Aerin Medical Inc. is the proper owner of the subject registration and has always been the owner of the Registration. Registrant intends to file a Section 7 request to correct the error in the Registrant’s name to correctly identify the owner of the registration as “Aerin Medical Inc.” (without comma) but wishes to make this filing to void the “Change of Name” filing previously submitted and recorded at Reel/Frame 5662/0398.

5. Based on the foregoing, the chain of title for the subject Registration should not be considered altered by the incorrect change of name filing and the original Registrant, "Aerin Medical, Inc.", should be listed as the owner of the Registration.

All of the foregoing statements are made of my own knowledge and are true.
