CONFIRMATORY ASSIGNMENT

This Confirmatory Trademark Assignment (the "Assignment") is made and entered into effective as of March 16, 2015 (the "Effective Date"), by and between Conecuh Ridge Distillery, Inc., an Alabama corporation ("Assignor") and Conecuh Ridge Distillery, LLC, a Delaware limited liability company ("Assignee" and together with Assignor, the "Parties").

WITNESSETH:

WHEREAS, Assignor was the owner of the United States Trademark Registration No. 3,763,086 for the mark CLYDE MAY'S (hereinafter the "Trademark");

WHEREAS, Assignor assigned to Assignee all of Assignor's right, title and interest in and to the Trademark and registration, together with all goodwill associated with the Trademark on March 16, 2015; and

WHEREAS, the Parties wish to confirm in writing the Assignment of the Trademark, registration and goodwill associated with the Trademark;

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties agree as follows:

1. Assignment: Assignor hereby confirms that as of March 16, 2015, it granted, assigned and conveyed to Assignee all of its right, title and interest in and to the Trademark, Registration No. 3,763,086, together with all goodwill associated with the Trademark, and the right to sue and recover any damages and profits and all other remedies for past, present and future infringements or violations thereof, if there may be any, the same to be held and enjoyed by the Assignee as it would have been held and enjoyed by the Assignee had the sale, assignment, transfer and conveyance not been made.
2. Title: Assignor hereby represents and warrants that it has not heretofore granted any license, right or privilege with regard to the Trademark or Registration No. 3,763,086, or in any other way encumbered the same, and that it had the full right to convey, free of licenses and encumbrances, all right, title and interest in and to the Trademark as of the Effective Date of this Confirmatory Assignment.
3. Cooperation: Assignor agrees to execute, acknowledge and deliver, or cause to be executed, acknowledged and delivered, such further instruments and documents and to perform such further acts as may be reasonably requested by

Assignee to effectuate more fully the transactions contemplated by this Confirmatory Assignment. Assignor consents and authorizes Assignee or Assignee's designee to file and record this Confirmatory Assignment as necessary to perfect title in Assignee.

4. Binding Effect. The terms, covenants and provisions of this Confirmatory Assignment shall inure to the benefit of Assignee, its successors and other legal representatives, and shall be binding upon Assignor, its successors, assigns and other legal representatives.
