RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE dated as of February 11, 2016 (this "Release") is made by Bank of America, N.A., successor by merger to LaSalle Bank Midwest National Association, formerly known as Standard Federal Bank (the "Releasor").

WHEREAS, pursuant to the Security Agreement dated November 22, 1996 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), and recorded in the records of the United States Patent and Trademark Office at Trademark Reel 001516, Frame 0064, Big Boy Restaurants International LLC, formerly known as Liggett Restaurant Enterprises, LLC, assignee of the entire interest in the trademarks from Elias Brothers Restaurants, Inc. (the "Debtor") granted to Comerica Bank, as Collateral Agent, a security interest in the Debtor's trademarks (the "Trademarks"), including but not limited to the Trademarks listed on attached Exhibit A.


