THIS DEED OF ASSIGNMENT is made on 15/7/2013

BETWEEN

- (1) **ITV NETWORK LIMITED**, a company incorporated in England and Wales (registered number 00603893) whose registered office is at The London Television Centre, Upper Ground, London, SE1 9LT ("Assignor");
- (2) **ITV RIGHTS LIMITED**, a company incorporated in England and Wales (registered number 06633451) whose registered office is at The London Television Centre, Upper Ground, London, SE1 9LT ("Assignee"); and

RECITALS:

- (A) The Assignor is the proprietor of the trade mark set out in the Schedule (the "Trade Mark").
- (B) The Assignor has agreed to assign the Trade Mark and the associated Goodwill to the Assignee on the terms set out in this Deed.

IT IS AGREED as follows:

1. **ASSIGNMENT**

The Assignor hereby assigns to the Assignee all legal and beneficial rights and title which it has in and to the Trade Mark, including, for the avoidance of doubt, such goodwill as it is able and may have in the Trade Mark, all rights to claim priority or seniority (if any) from any of the Trade Mark, all common law rights of the Assignor in relation to the Trade Mark and all rights of the Assignor to sue for past, present or future infringements, passing off and damages in relation to any and each of the Trade Mark.

2. **FURTHER ASSURANCE**

The Assignor shall execute all such documents and do all such acts as may be necessary to enable the Assignee to register the assignment contemplated at Clause 1 with the relevant local Trade Mark Registry and to otherwise give effect to the terms of this Deed.

3. **GOVERNING LAW AND JURISDICTION**


- 3.1 The validity, construction and performance of this Agreement shall be governed by and construed in accordance with the laws of England and Wales.
- 3.2 Each party agrees to submit to the exclusive jurisdiction of the High Court of England and Wales over any claim, dispute or matter arising under or in connection with this Deed.


