

ASSIGNOR will perform all acts that may be necessary or desirable to perfect the above-described transfer of the Registration to ASSIGNEE, as well as to cooperate in obtaining and/or providing information required in any proceedings relating to the Registration and/or trade names.

ASSIGNOR further authorizes the Commissioner of Patents and Trademarks of the United States to issue any and all additional registrations or amended registrations that have been or may be granted upon any application or petition for same, to ASSIGNEE, its successors and/or assigns.
