**CERTIFICATE OF AMENDMENT
OF THE
CERTIFICATE OF INCORPORATION
OF
YOUNG WOMEN'S CHRISTIAN ASSOCIATION OF THE
UNITED STATES OF AMERICA, INC.**

(Under Section 803 of the Not-for-Profit Corporation Law of the State of New York)

FIRST: The name of the corporation is YOUNG WOMEN'S CHRISTIAN ASSOCIATION OF THE UNITED STATES OF AMERICA, INC. (the "Corporation"). The name under which the Corporation was formed is NATIONAL BOARD OF THE YOUNG WOMEN'S CHRISTIAN ASSOCIATIONS OF THE UNITED STATES OF AMERICA.

SECOND: The Corporation was originally formed on June 5, 1907, under Chapter 422 of the Laws of 1907.

THIRD: The Corporation is a corporation as defined in subparagraph (5) of paragraph (a) of section 102 of the Not-for-Profit Corporation Law.


FOURTH: The Certificate of Incorporation is amended as follows:

Article I of the Certificate of Incorporation regarding the name of the Corporation is hereby amended to read in its entirety as follows:
