This Assignment supersedes all other contracts, agreements and understandings between Assignor and Assignee which, whether written or oral, expressed and/or implied regarding, referencing, and/or in any way concerning the Trademarks ("Prior Agreements"), and with the signing of this Assignment, the Prior Agreements are of no further force or effect.

Assignor hereby confirms and represents that all rights and permissions in the Trademarks given by Assignor to any other person or entity including, but not limited to, Rachel Wenzel, LegalForce RAPC have been terminated.
