**Recitals**

A. By that certain (i) Collateral Assignment of Patents, dated as of February 24, 2009 (the "Patent Security Agreement"), and recorded with the United States Patent and Trademark Office on March 11, 2009 as Reel/Frame 022390/0341, and (ii) Collateral Assignment of Trademarks, dated as of February 24, 2009 (together with the Patent Security Agreement, the "Security Agreement"), and recorded with the United States Patent and Trademark Office on March 3, 2009 as Reel/Frame 3945/0355, TerraLux, Inc., a Delaware corporation (the "Borrower"), granted to the Assignor a security interest in the patents listed on Exhibit A hereto (the "Patents") and the trademarks listed on Exhibit B hereto (the "Trademarks") hereto.

B. The indebtedness secured by such security interest has been paid in full as of the Effective Date.

**Termination and Release**

In consideration of the foregoing and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignor hereby terminates the Security Agreement and releases its security interest in the Patents and the Trademarks as of the Effective Date without recourse or warranty.
