**Release Of Security Interest In Trademarks Dated September 30, 2015**

This Release of Trademark Security Agreement ("Release") is made effective the date of last signature below ("Effective Date"), by Computershare Trust Company, National Association, as Trustee and Collateral Agent, in favor of the companies set forth on Schedule A (collectively, "Released Party").

WHEREAS, reference is made to the Indenture ("Indenture"), dated as of December 20, 2013, among FriendFinder Networks Inc. ("FFN"), Interactive Network, Inc. ("INI" and together with FFN, the "Issuers"), the Guarantors party thereto ("Guarantors") and Computershare Trust Company, National Association, as Trustee and Collateral Agent, ("Trustee and Collateral Agent") related to the Issuers' 14% Senior Secured Notes due 2018 (capitalized terms used herein and not otherwise defined herein have the meaning given to such terms in the Indenture) and to the Security and Pledge Agreement and the other Note Documents to which Streamray Inc. (together with FFN, the "Sellers") and Danni Ashe, Inc., GMCI Internet Operations, Inc., GMI On-Line Ventures, Ltd., General Media Communications, Inc., General Media Entertainment, Inc., Great Ganilly Enterprise Limited, NAFTA Media, S.L., Network Domain Services N.V., PMGI Holdings Inc., Penthouse Clubs International Establishment, Penthouse Digital Media Productions Inc., Penthouse Images Acquisitions, Ltd., Pure Entertainment Telecommunications, Inc., Streamray Studios Inc., Tan Door Media Inc., XVHUB Group Inc. ("Acquired Companies"), each a Guarantor and Subsidiary, are parties.

WHEREAS, the Sellers are selling all of their stock in the Acquired Companies ("Sale Stock"). Pursuant to Sections 9.2 and 10.7 of the Indenture, the Trustee and the Collateral Agent are releasing (a) the Liens in the Sale Stock, and (b) the Acquired Companies from all their obligations under the Indenture, the Guaranty and the Security Documents to which they are parties, including the Liens on the Collateral granted by the Acquired Companies.

WHEREAS, in connection with the Security Documents, Released Parties granted to Trustee and Collateral Agent, a security interest in, among other things, certain Licenses, Trademarks, goods and other rights (collectively, the "Trademark Collateral"), including without limitation, the Trademarks set forth in Schedule B attached hereto.

WHEREAS, in connection with the security interest in the Trademark Collateral dated September 30, 2015, documentation may have been recorded with the United States Patent and Trademark Office on December 1, 2015, and at reel 5678 and frame no 0727. (Trustee and Collateral Agent authorizes and requests FFN, or its authorized agent, to insert the recordation number if known before filing with the U.S. Patent and Trademark Office).

WHEREAS, Trustee and Collateral Agent has the requisite power and authority to release and discharge the security interest in and to the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, from and after the date of this Release, the Trustee and the Collateral Agent hereby releases, terminates and remits to Released Parties any and all right, title and interest in and to its security interest in and to the Trademark Collateral, including without limitation, the Trademarks identified in Schedule B, and reassigns any and all interest it may have in such Trademark Collateral to Released Parties. The Trustee and Collateral Agent hereby authorizes the Released Parties or Released Parties' authorized representative to record this Release with the United States Patent and Trademark Office.
