## INTELLECTUAL PROPERTY ASSIGNMENT

This **INTELLECTUAL PROPERTY ASSIGNMENT** (this "Assignment"), dated as of January 22, 2015 (the "Effective Date"), is by and between Ryan M. Powell and Ryan Powell Lacrosse, LLC. (hereinafter referred to individually and collectively as "Assignor") and Lacrosse Holding, LLC, a Connecticut limited liability company ("Assignee").

### **WITNESSETH:**

**WHEREAS**, Assignor is the owner of all right, title and interest in and to the trademarks (the "Trademarks"), copyrights (the "Copyrights"), and domain registrations (the "Domain Names") described on Schedule A attached hereto (collectively the Trademarks, Copyrights and Domain Names referred to herein as the "Intellectual Property"); and

**WHEREAS**, Assignor and certain other parties have entered into an Agreement (the "Agreement"), dated as of the date hereof, pursuant to which Assignor has agreed to assign all of his/its/their right, title and interest in and to the Intellectual Property to Assignee.

**NOW, THEREFORE**, in consideration of the transactions contemplated by the Agreement and in this Assignment and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Assignment. Assignor hereby sells, transfers, conveys, and assigns unto Assignee all right, title, and interest in and to the Intellectual Property and any and all goodwill of the business associated with the Intellectual Property, including without limitation the rights to any registrations thereof, the rights to prosecute any applications therefor, the rights to have any registrations issue in the name of Assignee, the rights to apply for and obtain any renewal of any registrations thereof, the rights to any priorities based on the filing of the aforesaid applications, the rights to sue for past and future infringement thereof, the rights to all works based upon, derived from, or incorporating the Copyrights, and the rights to all income, royalties, damages, claims and payments now or hereafter due or payable with respect to the Intellectual Property, and the rights in and to all causes of action, either in law or in equity for past, present, or future infringement based on the Intellectual Property.

2. Further Assurances. Each party will, promptly upon the other party's request and for no additional consideration, execute and deliver any and all additional documents and take such actions that are reasonably necessary to further effect and perfect the transfer of rights and assumption of liabilities and obligations set forth herein. Without limiting the foregoing, Assignor agrees to, on the Effective Date or, if not possible to do so on the Effective Date, as soon thereafter as possible, but in no event more than ten (10) days after the Effective Date, execute, acknowledge and deliver all appropriate domain name transfer documents, including without limitation the registrant name change agreement, with respect to the Domain Names and all documents necessary to change the administrative contact and the technical contact for the Domain Names and any additional information required by the registrar for the Domain Names as may be required to evidence or effectuate the conveyance and assignment of the Domain Names to Assignee.

3. Representations, Warranties and Covenants. This Assignment is subject to the terms and conditions of the Agreement, including the applicable representations, warranties, covenants, indemnities and other agreements and obligations relating to the Intellectual Property contained in the Agreement, which provisions are incorporated herein by reference, and constitute an integral part of this Assignment and shall survive the execution and delivery of this Assignment.

4. Binding Provisions. This Assignment is binding upon, and inures to the benefit of, the parties hereto and their respective heirs, executors, legal representatives, successors, and permitted assigns.

5. Governing Law. All questions concerning the construction, validity and interpretation of this Assignment and the performance of the obligations imposed by this Assignment shall be governed by the internal law, not the law of conflicts, of the State of Connecticut.




